### TREASURER'S REPORT

Presented amended FY2022 Budget. Presented FY2021 Budget vs. Actual Profit and Loss.

Third quarter sewer bills and Summer 2022 Property Tax bills have been sent out.

## **COMMITTEE REPORTS**

**SEWER** – Kahrs, *committee chair*. June influent slightly below average. Weed control is underway.

**BUILDING & GROUNDS** – Kahrs, *committee chair.* Trees along East Street need to be replaced. Paint color selected for Village Office, Village Hall, and DPW buildings. Village Hi-Lites put together and delivered.

On a motion by Kahrs, supported by Palinski, to purchase street banners to be placed along Waterloo and Main Streets with a price not to exceed \$2.000.00.

Roll call: Ayes: Morris, Frary, Palinski, Kahrs, and Bennitt. Nays: 0. Motion carried.

**STREETS** – Morris, *committee chair*. Need to look at other alternatives to snow plowing; extensive repairs needed to have snowplow truck pass DOT inspection. Attempting to get quotes to get street paving/repairs done in 2023.

**SIDEWALKS -** Palinski, *committee chair*. Jerry's Concrete has recommended some modifications to the scope of the sidewalk work. On a motion by Frary, supported by Kahrs, to accept Jerry's Concrete recommended changes to Sidewalk project.

Ayes: 5. Nays: 0. Motion carried.

**ZONING** – Frary, *committee chair*. First quarterly meeting for the Planning Commission is scheduled for Monday, July 18, 2022, at 7:00 p.m. at the Casnovia Village Hall.

**DISMANTLED CARS** – Bennitt, committee chair. No report.

#### **NEW BUSINESS**

- On a motion by Frary, supported by Palinski, to have Consuelo Morris, President, attend the Michigan Association of Mayors conference in August 2022, at a cost of \$150.00 Roll call: Ayes: Morris, Frary, Palinski, Kahrs, and Bennitt. Nays: 0. Motion carried.
- Ordinance 2022-03 Compensation to be Paid to the President and Trustees of the Village. On a
  motion by Kahrs, supported by Frary, to adopt Ordinance 2022-03 allowing board members to be
  paid on a quarterly basis instead of an annual basis. Roll call: Ayes: Morris, Frary, Palinski, Kahrs,
  and Bennitt. Nays: 0. Motion carried.
- On a motion by Frary, supported by Palinski, to transfer \$1,650.70 from the Major Street Fund, \$439.96 from the Local Street Fund, and \$492.63 from the Sewer Fund for a total of \$2,583.31 to the General Fund. Roll call: Ayes: Morris, Frary, Palinski, Kahrs, and Bennitt. Nays: 0. Motion carried.
- Resolution 2022-04 Equipment Fund Elimination. On a motion by Frary, supported by Palinski, to adopt Resolution 2022-04 eliminating the need for the Village to pay rent on Village-owned equipment. Roll call: Ayes: Morris, Frary, Palinski, Kahrs, and Bennitt. Nays: 0. Motion carried.

- Will send Commissioner Pego a proposed plan to accept the Muskegon County Senior Millage funds for the Village of Casnovia in the amount of \$4,462.00.
- Will send out bids for repairs to the concrete at the Veteran's Memorial.
- Village website discussion is tabled until the August meeting.
- On a motion by Frary, supported by Kahrs, to raise the wage of the DPW Manager to \$20.00 per hour. Roll call: Ayes: Morris, Frary, Palinski, and Kahrs. Nays: Bennitt. Motion carried.
- On a motion by Palinski, supported by Bennitt, to create a Continuing Education Fund and to transfer \$600.00 from the General Fund into the Continuing Education Fund. And to continue to transfer \$600.00 at the beginning of every fiscal year with a maximum balance of \$1,200.00 into the Continuing Education Fund. Roll call: Ayes: Morris, Frary, Palinski, Kahrs, and Bennitt. Nays: 0. Motion carried.

## **OLD BUSINESS**

- On a motion by Palinski, supported by Bennitt, to create a Budget Stabilization Fund and to transfer 5% of FY2021 net income in the amount of \$6,590.00 from the General Fund into the Budget Stabilization Fund. Roll call: Ayes: Morris, Frary, Palinski, Kahrs, and Bennitt. Nays: 0. Motion carried.
- On a motion by Palinski, supported by Bennitt, to create a Vehicle Fund and to transfer 8% of FY2021 net income in the amount of \$10,550.00 from the General Fund into the Vehicle Fund. Roll call: Ayes: Morris, Frary, Palinski, Kahrs, and Bennitt. Nays: 0. Motion carried.

Being no further business to come before the Council, on a motion by Palinski, supported by Frary, to adjourn at 8:45 p.m.
