CLERK'S REPORT

Animal Control was called on May 11: Resident at 61 Grand alleged a dog from 47 Grand bit him. Also received a letter from a resident with significant concerns about this same animal. Will call sheriff's department to see if there is a legal solution to this problem before someone gets seriously hurt. Requested a quote from Swift Door to repair the locking mechanisms on the east entrance door to the Office, the south

side door to the Hall and the door between the hall and the storage room; will continue to look for additional quotes.

TREASURER'S REPORT

Millage request packet forwarded to Casnovia and Tyrone Townships. Delinquent sewer bills have been forwarded to townships to be included on the property tax bills. Will investigate how to legally have ordinance violation fines transferred to property taxes when fines are not paid.

COMMITTEE REPORTS

SEWER – Kahrs, *committee chair.* Will run a short discharge at the end of the month to ensure ponds will not overfill before October. Weeds are becoming an issue with the warmer weather; will have to apply weed killer soon. Removed some small trees around the pond. Had to relocate turtles from the valve cell.

STREETS - Morris, committee chair. Contact Muskegon and Kent counties for pricing on repairing Village streets.

BUILDING & GROUNDS – Kahrs, *committee chair*. Trees have been planted along S. Main Street. Three storm drains needed to be cleared of grass clippings; request residents to refrain from mowing grass toward the street. Working with Nutt Painting to get the Village building painting project underway. Mowed the street easement of the property at 46 Probasco. Cleaned up the Tom Bolt Highway memorial.

SIDEWALKS - Palinski, committee chair. Sidewalk project on E. and W. Waterloo to begin the week of July 4.

ZONING – Frary, *committee chair*. Will check with consulting firm for pricing to help with the Zoning Master Plan updates.

DISMANTLED CARS - Bennitt, committee chair. One vehicle from 86 N. Main has been moved.

- Fall Street Sweeping and Leaf Pickup dates will be October 31, November 7, and November 14.
