SEWER – Kahrs, *committee chair*. Will be discharging and pulling sewer samples. There were unknown chemicals dumped in the sewer which caused chemical imbalance in one of the cells. Pulled tall weeds from sewer. Increase in sewer fees January 2023, would like to compare to other like-community fees.

BUILDING & GROUNDS – Kahrs, *committee chair*. Office furnace filters have been changed. The large tree in the monument park has lights put up. The current snowplow truck is not running. The Hall Fund has enough money to get bids to refinish the floors.

STREETS – Morris, *committee chair*. Continue to investigate snowplow options. Post open position for snowplow driver with updated wages. Waiting on estimates for repaying of Village streets.

SIDEWALKS - Palinski, *committee chair*. Work will start in Spring, 2023. Consideration of expanding scope to include more sidewalk length on E. Waterloo.

ZONING – Frary, *committee chair*. Will present Village Improvement Opportunities and Solar Energy Ordinance to the Planning Commission at the October 17 meeting. Commission to make recommendations to the Council for possible ordinance concerning Alternative Energy within Village limits
