ORDINANCE NO. 2020-07

REAFFIRMING ORDINANCE NO. 1-02

ORDINANCE TO SECURE THE PUBLIC HEALTH, SAFETY AND GENERAL WELFARW OF THE RESIDENTS, VISITORS, AND PROPERTY OWNERS OF THE VILLAGE OF CASNOVIA, COUNTIES OF KENT AND MUSKEGON, MICHIGAN BY THE REGULATION OF DISPRDERLY CONDUCT AND OTHER UNLAWFUL CONDUCT BY PERSONS WITHIN THE VILLAGE, AND TO PRESCRIBE PENALTIES FOR THE VIOLATION THEREOF.

THE VILLAGE OF CASNOVIA REAFFIRMS ORDINANCE NO. 1-02, September 9, 2002:

SECTION 1. TITLE

This ordinance shall be known and may be cited as

The Village of Casnovia Disorderly Conduct Ordinance

SECTION 2. **DEFINITIONS**

The following term used in this ordinance is defined as follows: Public place shall mean any street, alley, park, public building, any place of business or any place of assembly and any other place which is open to the public view or to which the public has or may gain access.

SECTION 3. ACTS AND CONDUCT PROHIBITED

No person shall:

- (a) Commit an assault
- (b) Engage in any disturbance, fight or quarrel in a public place
- (c) Be drunk in any public place or under the influence of any narcotic drug in any public place.
- (d) Willfully destroy, remove, damage alter or in any manner deface any property not of his or her own.
- (e) Engage in peeking in the windows of any inhabited place.
- (f) Solicit or accost any person for the purpose of inducing the commission of any illegal act.
- (g) Disturb the public peace by loud, boisterous or seriously offensive conduct.
- (h) Allow any place occupied or controlled by such person to be a place used, frequented or occupied by noisy, boisterous, or disorderly persons.
- (i) Obstruct, resist, hinder, or oppose any member of a police force, or any police officer or sheriff's department officer in the discharge of his or her duties.
- (j) Knowingly furnish to any police officer or sheriff's department officer, or other Official a false name, false address, or false information in connection with any arrestor investigation.
- (k) Knowingly make to any police officer, sheriff's department officer, or other official, a fictious report of the purported commission of any crime or misdemeanor.
- (I) Trespass or unlawfully remain upon the premises of another, to the annoyance or disturbance of the lawful occupant or his or her agent.
- (m) Wrongfully throw or propel any snowball, missile or object from any moving motor vehicle.
- (n) Wrongfully throw or propel any snowball, missile or object toward any person or motor vehicle.
- (o) Purchase or knowingly possess or transport any alcoholic liquor, or knowingly possess, transport or have under his or her control in any motor vehicle any alcoholic liquor, if such person is under 21 years, unless such person is licensed to do so and is possessing, transporting or having such alcoholic liquor in a motor vehicle under his or her control during regular working hours and in the course of employment.

SECTION 4. VIOLATIONS AND PENALTIES

Any person, firm or corporation who shall violate any of the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction thereof, shall be punished by a fine of not to exceed \$500.00 together with court costs, in the discretion of the court. Each day that such violation occurs shall constitute a separate offense.

SECTION 5. VALIDITY

Each of the provisions of this ordinance is declared to be separate and severable. If any court should hold that any section or provision hereof is invalid, such holding shall not affect of impair the validity of any other section, term or provision of this ordinance.

SECTION 6: **EFFECTIVE DATE AND PUBLICATION**

This ordinance shall become effective 20 days after its publication or 20 days after a summary of its provisions is published in a local newspaper of general circulation.
