**ORDINANCE NO. 2020-09**  
**(COMBINING OF ORDINANCES NO. 01-03 AND 19-01)**

**AN ORDINANCE TO AMEND THE VILLAGE OF CASNOVIA**  
**SANITARY SEWER, USE, CONNECTION AND RATE**  
**ORDINANCE SO AS TO REVISE THE COMBINED TRUNKAGE CONNECTION AND**  
**AVAILABILITY FEE AND SERVICE STUB CHARGE**

THE VILLAGE OF CASNOVIA ORDAINS:

WHEREAS, the Village Council of the Village of Casnovia adopted Ordinance NO. S-1, the Village of Casnovia Sanitary Sewer Use, Connection and Rate Ordinance on July 10, 1972;

WHEREAS, such Ordinance was amended by the following Village of Casnovia ordinances: An Ordinance adopted December 13, 1977; Ordinance NO. S-2, adopted June 25, 1980; Ordinance NO. 97-1, adopted February 10, 1997; Ordinance NO. 99-2, adopted March 8, 1999; Ordinance NO. 00-2, adopted December 11, 2000; Ordinance NO. 01-03, adopted January 13, 2003; Ordinance NO. 16-06, adopted December 11, 2006 (collectively the "Sewer Ordinance"); and Ordinance NO. 19-01, adopted October 14, 2019; and

IT IS THEREFORE ORDAINED:

**SECTION 1. Amendment of Section 6.01(a).** Section 6.01(a) of the Sewer Ordinance is hereby amended in its entirety to read as follows:

Section 6.01.

- (a) Charges for sewage disposal services to each premises within the Village connected with the sewage disposal system shall be \$52.50 per unit, per quarter. Each year thereafter, effective July 1, the charge of the sewage disposal system shall increase by 5% (or to the closest whole number thereto) unless otherwise modified by the Village Council.

**SECTION 2. Continuing Effect.**

This ordinance amends the Sewer Ordinance only as specifically stated herein. All other provisions in said ordinance remain in full force and effect according to their terms, and as they may have previously been amended.

**SECTION 3. Severability.**

The sections and provisions of this ordinance are severable and any portion which is declared inoperative or invalid for any reason by a court of competent jurisdiction shall in no way affect the remaining sections or provisions of this ordinance.

THE VILLAGE OF CASNOVIA ORDAINS:

WHEREAS, the Village council now desires to further amend Ordinance NO. S-1, so as to adjust charges for the combined trunkage connection and availability fee and service stub charge.

**SECTION 1.** Section 3.03. as adopted by Amending Ordinance NO. S-2 dated June 25, 1980, is hereby amended so as to read in its entirety as follows:

Section 3.03 -- Owners of premises within the Village served by the system which are hereafter connected directly or indirectly to the sewers now or hereafter constructed in the area served by the system shall pay a combined trunkage connection and availability fee and service stub charge, totaling the sum of thirty-five hundred dollars (\$3,500.00) for each such unit assigned to said premises upon the basis of its proposed use. Such combined fee and charge for each unit shall be paid in full in cash at the time a building or construction permit is issued by the Village.

SECTION 2. This ordinance amends Ordinance NO. S-1 only as specifically stated herein. All other provisions in said ordinance remain in full force and effect according to their terms, as they may have previously been amended

**Effective Date.**

This ordinance or a summary of its provisions shall be published in the Village Newsletter and Website. The ordinance shall become effective upon the date of the publication and/or posting. The rate specified in Section 1 of this ordinance shall be effective for all bills commencing with the Village Sewer System's next billing quarter.
