COMMITTEE REPORTS

SEWER – Kahrs, *committee chair*. Replacement signs were picked up and are currently stored in the upper garage. The signs will be replaced once the weather gets a bit warmer.

Pond samples were pulled the week of May 2^{nd} . The sample reports with good numbers and the ponds will be discharged the week of May 8. The average daily flow dropped a little for the month of April but for the year they are up.

BUILDING & GROUNDS – Kahrs, *committee chair.* The Hall is all set for rentals, there are 2 rentals scheduled for June.

STREETS – Morris, *committee chair*. Continue to move forward with street repairs and hope for the approval of grants to complete the street repair work. The catch basins were cleaned May 2nd, 2023, by Plummers. Mr. J's has begun repairing lawns from winter plowing damage.

SIDEWALKS - Palinski, *committee chair*. Completed walk around the Village, with the concrete contractor, to review for the replacement and removal of sidewalks, as it relates to the master plan. Existing sidewalk quote was updated. Miss Digg will be contacted.

ZONING – Frary, *committee chair*. There have been no zoning concerns this month.

DISMANTLED CARS – Bennitt, *committee chair*. Reported on disabled vehicles. All but one have been removed. Notification was sent to the resident.
