ORDINANCE NO. ▲ 2024-09 – Amended Ordinance 2020-08 ▲

▲ AN ORDINANCE to establish Village of Casnovia Ordinance 2024-09 and to establish a Curfew for Minors and Parental Responsibility within the Village of Casnovia, to provide civil infraction penalties for the violation thereof. ▲

THE VILLAGE OF CASNOVIA ORDAINS:


▲ Section 1. Purpose: To permit the Village to establish a curfew for persons under the age of seventeen years from the public streets or other public spaces within the Village of Casnovia, , including public buildings and places of amusement and entertainment, from 10:00 p.m. to 6:00 a.m. local time, unless accompanied by his or her parent, guardian, or other adult person having the care, custody and control of such minor person, or if and when such minor person is upon an emergency errand or other legitimate business at the direction of his or her parent, guardian or other adult person having the care, custody and control of such minor person. Every person convicted of a violation of any provision of this ordinance shall be punished by a fine of not more than \$500.

Section 2. Definitions: Parental Responsibility - The following words, terms, and phrases, when used in this ordinance, shall have the meaning stated below in this section:

- a) No parent, guardian, or other adult person having the care, custody and control of a minor person under the age of seventeen years shall permit such minor person to be out upon the streets or other public places within the Village of Casnovia, including public buildings and places of amusement and entertainment, from 10:00 p.m. to 6:00 a.m., local time, unless such parent, guardian or other adult, person having the care, custody and control of such minor accompanies him or her, or sends such minor upon an emergency errand or other legitimate business on behalf of such parent, guardian or other adult person having the care, custody and control of such minor. (\$500.00) dollars and costs of prosecution or imprisonment for not more than ninety (90) days, or by both such fine and imprisonment. Each act of violation and every day upon which any such violation shall occur shall constitute a separate offense.


Section 3. **Repealed Ordinance 2020-08 - An Ordinance Establishing A Curfew For Minors and Parental Responsibility.**

Section 4. Severability: The provisions of this ordinance are hereby declared to be severable, and if any clause, sentence, paragraph, section or sub-section is declared to be void or ineffective for any reason, it shall not affect any other part or portion hereof.

Section 5. This ordinance shall become effective 30 days following its publication or the publication of a summary of its provisions in a local newspaper of general circulation in the Village. 


