Clerk's Report: Letters were sent to resident about dismantled vehicle, to resident who is parking between the sidewalk and street in his driveway obstructing other residents view of street, to resident regarding request for hidden driveway sign and notification that she cannot put up her own signs based on Michigan law, letter sent to resident regarding inoperable vehicles and property maintenance, letters sent to residents abutting Kruithoff property re: Fall leaf disposal on Kruithoff field, and letter sent to resident regarding tree trimming debris placed by roadside.

COMMITTEE REPORTS

Sewer – Kahrs, *committee chair*. Millings to be spread on Sewer drive when construction is completed, by fence at Sewer ponds. The projects scheduled at the sewer ponds have started and are getting close to completion. There are some questions regarding the outfall construction. There is duck weed on the primary ponds, which will be addressed after construction is

complete. There is a question regarding the new manhole in the NW area of the sewer ponds, not being level with the ground. The engineer is being contacted to discuss this manhole. We may need to find a different way to dispose of the brush after the fall pick up due to changes made during the sewer construction project.

Building & Grounds – Kahrs, *committee chair*. The hall was rented for a half day rental, the entire deposit was not returned due to some cleaning issues. There are additional rentals in September. We will start putting up the Fall banners. Would like to purchase new blinds for the hall. We have not received information from Consumers about the Christmas lights on the poles. **Streets** – Morris, *committee chair*. Street repairs will begin in Mid-September.

Sidewalks – Palinski, *committee chair*. There will be repairs to the sidewalks on Atherton and we will seek additional bids for sidewalk repairs for next spring/summer.

Zoning – Frary, *committee chair*. Nothing to report.

Dismantled Cars – Bennitt, *committee chair*. Request letter to be sent to resident regarding what appears to be a junk car on a trailer.
